Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information

Preface

Securities and Exchange Board of India (SEBI) has notified SEBI (Prohibition of Insider Trading) Regulations, 2015 vide its Circular No. LAD-NRO/GN/2014-15/2185 dated 15th January, 2015 which is to be effective from 15th May, 2015.

This code (Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information") is formulated according to Regulation 8 of Chapter – IV of SEBI (Prohibition of Insider Trading) Regulation, 2015.

The company's is committed to preserve the confidentiality of un-published price sensitive information and to prevent the misuse of such information. In order to achieve these objectives and in compliance with the aforesaid SEBI regulations, Raja Bahadur International Limited (" t h e C o m p a n y ") hereby notifies this Code.

Principles of Fair Disclosure of Unpublished Price Sensitive information.

The Company will adhere to the following so as to ensure fair disclosure of events and occurrence that could impact price of its securities in the market.

1. The Company will make prompt public disclosure of unpublished price sensitive information that would impact price discovery no sooner than credible and concrete information comes into being in order to make such information generally available.
2. To avoid selective disclosure the Company will make uniform and universal dissemination of unpublished price sensitive information.
3. The Company Secretary / Compliance Officer of the Company shall act as the Investor Relations Officer to deal with dissemination of information and disclosure of unpublished price sensitive information unless otherwise decided by the Board of Directors.
4. The Company will make prompt dissemination of unpublished price sensitive information that gets disclosed selective, inadvertently or otherwise to make such information generally available.
5. The Company will provide appropriate and fair response to queries on news reports and requests for verification of market rumors by regulatory authorities.
6. The Company will ensure that information shared with analysts and research personnel is not published price sensitive information.
7. The Company will develop best practices to make transcripts or records of proceedings of meeting with analysts and other investor relations conferences on the official website to ensure official confirmation and documentation of disclosures made.
8. The company will handle all unpublished price sensitive information on a need-to-know basis.

Disclosure of the Code For Public Information

This Code shall be hosted on the website of the Company.

This Code and every subsequent amendment made thereto shall be prompt intimated to the Stock Exchange where the securities of the Company are listed.
